#### Abstract

Most of the glycosidic aroma precursors in grape consist of diglycosides such as rutinoside. Yeast glycosidases have been extensively studied but their activity is limited to monoglucosidic precursors. Yet, there is no study about application of glycosidases active on rutinoside in grape. In this study, we screened *Bacillus* isolates for their glycosidase activities on rutin and grape aroma precursors. One *Bacillus amyloliquefaciens* and one *Bacillus licheniformis* strains produced extracellular glycosidases, active on both rutin and *p*aranitrophenol-α-L-rhamnoside. The specific rutinosidic activities were 14 and 9.0 μkat/mg respectively, and supernatants were active on Muscat grape glycosidic aroma precursors. Both strains were able to release monoterpenoids and benzenoids. The most released monoterpenoid in grape pomace was neric acid, with 378 μg/kg and the most released benzenoid was 2-phenylethanol, with 189 μg/kg for *B. licheniformis*. These glycosidases are interesting tools to target rutinosidic glycosides in grape and can be applied as a new way of valorising grape pomace.

#### Introduction

Fruit and vegetable transformation generates tons of by-products every year. Although byproducts used to be considered as "waste", it is nowadays accepted that they are resourceful and can be reused as colorants, source of proteins and dietary fibres and can hold some antioxidants activities (Gowe, 2015). They are also studied for their aroma potential through their high quantity of glycoside aroma precursors (Liang et al., 2020). A glycoside is a molecule, generally a volatile compound or polyphenol, bound to a sugar moiety. Most of the glycosides are not degraded during fruit and vegetable processes and they are part of byproducts. The hydrolysis of these glycosides is conducted by acid or enzymatic hydrolysis. Acid hydrolysis leads to chemical transformations, like terpenic rearrangements or oxidations, of the released volatile compounds (Dziadas & Jeleń, 2016) and is therefore less studied nowadays. Enzymatic hydrolysis is the most widespread hydrolysis tool employed to free volatile compounds from glycosidic precursors. Some industrial glycosidases are AR2000 and Rapidase X-press (DSM, Delft, The Netherlands), Pectinol and Rohapect C (AB Enzymes GmbH, Darmstadt, Germany) and Aromase (Amano Enzyme Co., Nagoya, Japan). These enzymes are already used to release aroma precursors from several matrices, such as tea (Zhang et al., 2020), hop (Holt et al., 2019), strawberry (Gaborieau et al., 2018) or grape (Sarry & Günata, 2004). They are also industrially employed to enhance varietal aromas in wine or tea (Ni et al., 2021; Sun et al., 2018). Furthermore, the released volatiles can also be extracted from the matrix. Although it is still not quite common, new sources of natural flavours, produced from by-products, would be interesting for perfume industries as the consumer is more and more aware of the sourcing of its cosmetic products.

56 However, most of enzymes employed today are a mixture of several enzymes produced by 57 fungi. They exhibit side activities that might release undesired aromas during the enzymatic process, which impact the organoleptic properties of the produced wine (Fia et al., 2016). 58 59 Screening of more specific glycosidases is a strategy that can overcome the off-flavours 60 release. The matrix needs however to be well characterised as glycosidic moieties can be 61 widely different from one matrix to another. Grapes received extensive attention throughout 62 the years and are still today the most studied matrices in terms of glycosidically bound 63 volatiles. Main glycosides in grape are constituted of 6-O-α-L-arabinofuranosyl-β-D-64 glucopyranosides, 6-O-β-D-apiofuranosyl-β-D-glucopyranosides (acuminose) and 6-O-α-L-65 rhamnopyranosyl-β-D-glucopyranoside (rutinose) (Liang et al., 2s020). Numerous studies focused on the application of yeasts and lactic acid bacteria (LAB) glycosidases on grape 66 67 (Hernandez-Orte et al., 2009; Tufariello et al., 2021). These glycosidases are mainly active on monoglycosides of β-D-glucose, which are not the main glycosides in grape The use of 68 69 diglycoside-specific glycosidases (diglycosidases) would allow a more complete release of 70 volatile compounds.. To our knowledge, only one study dealt with the incubation of a 71 rutinosidase with grape glycosides (Minig et al., 2011). For now, studies of such glycosidases 72 were mainly focused on fungi (Koseki et al., 2018). Yet, some bacteria are known to produce 73 diglycosidases (Neher et al., 2016) and among them *Bacillus* spp. have already shown activity 74 toward rutin (Yang et al., 2012; Zhu et al., 2017), one of the main glycosidic moiety in grape. 75 Such glycosidic moiety has also been identified in other matrices like acerola (Boulanger & 76 Crouzet, 2001), nutmeg (Ananthakumar et al., 2006), passion fruit (Chassagne et al., 1998) 77 and tobacco (Cai et al., 2013) for example. Thus, strains producing glycosidases active on 78 rutinosidic moieties could be used to enhance varietal aromas from industrial food products 79 or to produce natural flavours from by-products for perfume industries.

The aim of this study was to screen *Bacillus* isolates producing glycosidases active on rutin and grape glycosides. For this purpose, we screened *Bacillus* strains from our laboratory collection for their ability to produce diglycosidases. We then assessed their hydrolytic activity toward rutin and grape glycosides.

# **Material and Methods**

### 87 <u>Materials</u>

The p-nitrophenyl (pNP) substrates pNP- $\beta$ -D-gluco-pyranoside (pNPG), pNP- $\beta$ -D-cellobioside (pNPC) and pNP- $\alpha$ -L-rhamno-pyranoside (pNPR) and the 5-bromo,4-chloro,3-indolyl- $\beta$ -D-cellobioside (BCIC, X- $\beta$ -D-Cellobioside) were purchased from Glycosynth (Cheshire, England. Grape (var *Muscat Italia*) was purchased from local market. Solid phase extraction (SPE) cartridges Isolute ENV+ (200 mg and 50 mg) were obtained from Biotage (Uppsala, Sweden). Rutin was purchased from Carbosynth Ltd (United Kingdom). An enzymatic preparation of pectinases and glycosidases, AR2000 was obtained from DSM (Delft, The Netherlands).

All other chemicals used were analytical reagents.

# Bacterial isolates used for the screening

The 20 isolates used were isolated from local market raw Vietnamese fermented pork sausages, *nem chua* (laboratory collection) (Lorn et al., 2021). They were obtained by successive streaks on LB agar medium with incubations for 24 h at 37°C and were positive for CMCase activities using the screening method described by Guo *et al.* (2017) (Guo et al.,

103	2017). They were cultured in LB-agar medium or LB broth at 37°C under orbital agitation.
104	When specified, LB was supplemented with 1% (w/v) CMC or rutin.

106	DNA extraction and molecular identification by 16S rRNA gene sequencing
107	Genomic DNA was extracted using the InstaGeneTM Matrix (Bio-Rad) as described
108	previously (Lorn et al., 2021). The V1-V9 regions of 16S rRNA gene were amplified using
109	primers 16S-27F (5'-AGAGTTTGATCMTGGCTCAG-3') and 16S-1492R' (5'-
110	TACGGYTACCTTGTTACGACTT-3'). DNA sequencing reactions were performed by
111	Eurofins Genomics (Germany) using both forward and reverse primers (16S-SeqF, 5'-
112	AGTAGGGAATCTTCCACA-3' and 16S-SeqR, 5'-CTTGCCACCTACGTATTA-3').
113	Taxonomic identification was determined by comparing the sequence of each isolate with
114	those reported in the basic BLAST database (https://blast.ncbi.nlm.nih.gov/Blast.cgi).
115	
116	Intracellular protein extraction
117	One millilitre of bacterial culture was centrifuged (10000 g, 5 min). Supernatant was collected

One millilitre of bacterial culture was centrifuged (10000 g, 5 min). Supernatant was collected for enzymatic activities. The pellet was washed three times with sterile distilled water (1 mL). 500 µL of the cell suspension were then shaken twice for 35 s at 6 m.s<sup>-1</sup> with 50 mg glass beads (Sigma, 100 µm diameter) in a FastPrep<sup>TM</sup> instrument (FP12, BIO101, MP Biomedicals Illkirch, France). After centrifugation (10000 g, 5 min), the supernatant was collected for intracellular enzymatic activities.

# Screening of BCICase activity

Bacterial isolates were cultured in LB-CMC (1% w/v) broth for 24 h at 37°C. Ten µL of culture were dropped on LB-CMC (1% w/v) agar plate supplemented with 0.01% (w/v) BCIC. Plates were incubated for 48 h at 37°C. When the aglycon was released in the medium, it was air-oxidized and it turned blue (Perry et al., 2006). Thus, blue colonies were observed for isolates showing positive BCICase activity.

Assay of enzymatic activities toward *Para*-nitrophenol-based activities (pNP-β-D-glucoside;

pNP-β-D-cellobioside; pNP-α-L-rhamnoside)

Activities toward nitrophenol-based glycosides were assayed following the protocol of Deshpande *et al.* (Deshpande et al., 1984) with adapted volumes for microplate reactions (10  $\mu$ L of sample were incubated in 90  $\mu$ L of *p*NP glycoside solution) and with 2.77 mM of *p*NPC. AR2000 was used as control. One international unit of  $\beta$ -glucosidase,  $\beta$ -cellobiosidase or  $\alpha$ -rhamnosidase activity ( $\mu$ kat) was defined as the amount of enzyme that produced 1  $\mu$ mol of *p*NP per seconde under the assay conditions.

Protein concentrations were determined according to the Bradford method (Bradford, 1976) with bovine serum albumin (BSA) as standard. Specific activities toward each substrate were expressed as units per milligram of protein.

#### Assays of rutinosidase activity

Assays of rutinosidase activity were conducted following the protocol established by Weiz *et al.* (Weiz et al., 2017) with the following modifications. Briefly, 50 μL of sample were incubated with 450 μL of 0.11% (w/v) rutin solubilized in sodium acetate buffer pH 5 and 5% (w/v) DMSO at 50°C for 24 h. One volume (500 μL) of ethyl acetate was added and mixed,

the tubes were then centrifuged (4200 g, 3 min). 50  $\mu$ L of supernatant were mixed with 960  $\mu$ L of sodium carbonate solution (50 mM, pH 10) and incubated at room temperature for 5 min. The absorbance was finally measured at 320 nm. One international unit of rutinosidase activity ( $\mu$ kat) was defined as the amount of enzyme that produced 1  $\mu$ mol of quercetin per seconde under the assay conditions.

# Extraction of grape glycosidic aroma precursors (glycosides)

Extraction of grape glycosides was conducted as followed. The grape juice was separated from the pomace using a juice extractor. It was centrifuged (4000 g, 10 min) and filtered through  $n^{\circ}4$  Whatman filter. Grape pomace (200 g) was suspended in 800 mL of phosphate buffer (150 mM, pH = 7.2) and incubated at room temperature in darkness under gentle agitation. After 24 h, the solution was centrifuged (4000 g, 10 min) and filtered.

For both matrices, Isolute ENV+ SPE cartridges (200 mg, 6 mL) were conditioned by adding 4 mL of methanol and then washed twice with 4 mL distilled water. Juice or pomace solution (60 mL) were loaded per SPE cartridge and washed twice with 4 mL distilled water. Free volatile compounds were eluted by 4 mL of a dichloromethane:pentane solution 1:2 (v/v). Glycoside bound volatiles were eluted with 4 mL of methanol. The fraction was evaporated to dryness under nitrogen stream and re-dissolved in 12 mL of sodium-acetate buffer (pH 5). The solution was rinsed three times with the same volume of a dichloromethane-pentane mixture. It was splitted into aliquots of 1.8 mL and conserved at -20°C until used.

# Enzymatic hydrolysis and SPE extraction

Aliquots of the glycoside solution were defrosted at room temperature. 200  $\mu$ L of AR2000 solution (45 g/L, sodium-acetate buffer, pH 5) or of the bacterial supernatant were added and the vials were incubated at 45°C under agitation for 120 h. At the end of the incubation, vials

were immersed in  $4^{\circ}$ C water bath to slow down the enzymatic reaction. 200  $\mu$ L of 4-nonanol (25 mg/kg, methanol) were added as internal standard and the solution was loaded into a preconditioned ENV+ SPE cartridge (50 mg, 3 mL). Cartridges were conditioned the same way as described above but volumes were divided per four. Free volatile compounds were eluted with 1 mL of a dichloromethane-pentane mixture and traces of water were removed by addition of anhydrous Na<sub>2</sub>SO<sub>4</sub>. Samples were concentrated under nitrogen steam up to 50  $\mu$ L before GC-MS analysis.

#### GC-MS chromatographic conditions

Measurements of released bound volatiles were performed using a gas chromatograph coupled with a mass spectrometer with an Electron Impact (EI) ionization mode (GC/MS, PerkinElmer, Clarus SQ 8 S, 580 series). GC was equipped with an Elite-5MS capillary column (30 m length, 0.25 mm inner diameter and 0.25 μm thick film). Helium was used as carrier gas at 1.0 mL/min and split ratio 1:10. The temperature of the injector was 250°C. The run time was recorded in full scan mode (50-350 *m/z* range). Peaks were identified by comparing their mass spectra and their linear retention index (LRI) with the NIST (National Institute of Standards and Technology, USA) library. Retention indices were determined by using a homologous series of *n*-alkanes (C8–C18) (table 1). They were quantified by comparison of their chromatographic peak areas with that corresponding to the internal standard (4-nonanol).

#### Statistical analysis

All experiments were carried out in three biological replicates. The data were analysed using analysis of variance (one-way Anova) and Tukey's Honestly Significant Difference test

(HSD) or *student* test (*t*-test) (the level of significance was 5%) by the MINITAB statistical software (version 19.2020.1.0).

#### **Results**

1) Screening of *Bacillus* isolates for diglycosidase activity

As most of grape aroma precursors are diglycosidic, the release of varietal aromas could be greatly improved by using exogenous microbial diglycosidases instead of the monoglycoside-specific glycosidases currently used. However, the lack of commercial diglycosides slows down the research on this topic. As there is no chromophore-based rutinoside available, we first screened the isolates for their diglycosidic activity toward  $\beta$ -D-cellobiose and then we quantified the rutin deglycosylation for the isolates showing the highest activities.

The most employed commercial  $\beta$ -D-cellobiose glycosides to measure diglycosidase activity are linked to methylumbelliferone or *para*-nitrophenol (Vlasenko et al., 2010). However, they are not convenient for colony-based screening methods. On one hand, the detection of released methylumbelliferone is fluorometric, and requires specific spectrophotometer. On the other hand, the yellow-colour of nitrophenolate makes the detection difficult in the same-coloured agar media. The 5-bromo,4-chloro,3-indolyl- $\beta$ -D-cellobioside (BCIC, X- $\beta$ -D-Cellobioside) is today not common for fast screening purpose but the detection of the activity is convenient because positive colonies turn blue (Perry et al., 2006). Diglycoside activities of positive isolates were then quantified using *p*NPC.

*Bacillus* spp. are soil bacteria that are found in many traditionally fermented products (Tamang et al., 2016). They are usually present in high protein food such as soybean, fish or meat products and display proteolytic, cellulolytic, amylolytic and lipolytic activities (Baruzzi

et al., 2006; Tamang et al., 2016; Vlasenko et al., 2010). Fermented pork sausage is known to be fermented not only with LAB but with *Bacillus* spp. too, which participates to the ripening of the final fermented product (Baruzzi et al., 2006). Twenty bacterial isolates from fermented pork sausage were subjected to BCIC screening (see supplemental S1). Isolates were cultured for 24 h at 37°C in LB agar supplemented with 1% CMC and 0.01% BCIC (w/v). They were all positives to glycosidase activity. They were identified by the mean of the sequencing of 16S rRNA. They all belonged to the *Bacillus* genus: eleven were *Bacillus* subtilis, four were *Bacillus thuringiensis*, four were *Bacillus licheniformis* and one was *Bacillus amyloliquefaciens*. In order to estimate the enzymatic activity, the 20 isolates were cultured for 72 h at 37°C in LB broth supplemented with 1% CMC (w/v) to induce enzyme production and supernatant activities toward pNPC were assayed (Figure 1).

The activities ranged from 0.11 nkat/mL (strain *B. thuringiensis* 2-62e) to 1.3 nkat/mL (strain *B. subtilis* 3-8a). *B. subtilis* strains generally showed highest activities, followed by the strain *B. amyloliquefaciens* 1-38c and *B. licheniformis* strains. *B. thuringiensis* strains exhibited the lowest activities toward *p*NPC in our study. Means were compared by the Tukey test at the 5% probability level for each isolate within the same species. The isolate giving the greatest activity was chosen, namely *B. subtilis* 3-8a, *B. thuringiensis* 2-1a, *B. liqueniformis* 4-4a and *B. amyloliquefaciens* 1-38c. These isolates were used for future enzymatic activities.

2) Specific activities of selected *Bacillus* strains toward *pNPG*, *pNPR* and rutin

To induce diglycosidases production in the screened *Bacillus* spp., grape diglycoside moieties need to be employed. Main grape diglycosides are rutinose, acuminose and  $6-O-\alpha$ -L-arabinofuranosyl- $\beta$ -D-glucopyranosides. The two latter glycosides are not commercially available and need to be extracted from plants (Sakata et al., 2003). Production of

rutinosidases can be induced by adding rutin in the culture medium (Neher et al., 2016) and some *Bacillus* sp. degrading rutin have already been found (Yang et al., 2012; Zhu et al., 2017).

Thus, the four strains were cultured in LB broth supplemented with 1% rutin (w/v) for 72 h at  $45^{\circ}$ C. Intracellular activities were evaluated on the *pNPG* and *pNPR* substrates but they were below the detection limit of the method. Specific *para*-nitrophenol ( $\beta$ -D-glucoside and  $\alpha$ -L-rhamnoside) glycosidases and rutinosidase extracellular activities were assayed. No extracellular activities toward *para*-nitrophenol- $\beta$ -D-glucoside were detected. The highest results toward *pNPR* and rutin were obtained at 72 hours of culture (**table 2**).

Among the four strains, B. amyloliquefaciens and B. licheniformis had activities toward both substrates whereas no activity was detectable for B. thuringiensis. B. subtilis was active toward pNPR but not toward rutin. The pNPR activity has already been characterised in Bacillus sp. with wide range of specific activity (Hashimoto et al., 1999; Jung et al., 2006). Rutinosidase activities for *B. amyloliquefaciens* and *licheniformis* were 0.62 and 0.41 pkat/mg respectively. In 1990, Sang-Joon et al. (Sang-Joon et al., 1990) purified an enzyme from Arthobacter sp., which displayed 1.9 µkat/mg specific rutinosidase activity. To our knowledge, this is the only quantified bacterial specific activity to this date. Rutin deglycosylation by bacteria is usually shown in relative hydrolysis compared to initial substrate concentration (Zhu et al., 2017). Thus, our results could not be compared with those obtained for other *Bacillus* strains. However, activities toward rutin were in the range as those detected for native buckwheat flour enzymes by Weiz et al. (Weiz et al., 2017) who first proposed the quantification technique we employed. AR2000 is a commercial mixture of enzymes derived from Aspergillus niger containing multiple glycosidase activities. It was used in this study as a control. Specific activities of the strains B. amyloliquefaciens and B. licheniformis were similar to those obtained for AR2000. These results were in accordance

with previous study which showed that the specific activity of AR2000 toward α-Lrhamnoside-based substrate was the lowest compared to other glycosidic moieties (Sarry & Günata, 2004).

3) Activities of selected *Bacillus* strains on glycosidic aroma precursors extracted from grape juice

Diglycosides constitute the main glycosides in grape and rutinosidic glycosides account for one of the highest (Liang et al., 2020). B. amyloliquefaciens 1-38c and B. licheniformis 4-4a supernatants were active on rutin and the two others were not. The extracellular activities of the four strains toward glycosidic aroma precursors extracted from grape juice were assayed. The released volatile compounds for each strain were measured in the gas phase using a GC-MS and are shown in table 3.

281 Compounds were classified into three classes, namely monoterpenoids, benzenoids and 282 283 284 285 286 287

norisoprenoids. In total, the incubation with AR2000 released 4101 µg/kg of aroma precursors, 176 with B. licheniformis, 136 with B. amyloliquefaciens, 76 with B. thuringiensis and 88 µg/kg of aroma precursors with B. subtilis. Glycoside hydrolysis led by AR2000 (4.5 g/L) was used as control and was considered as being 100% of total enzyme hydrolysis due to its various substrate activities (Palomo et al., 2005). Its hydrolysis led to higher content of monoterpenoids and benzenoids than C13-norisoprenoids. These results are in accordance with previous studies, which showed that Muscat grape are characterised by floral aroma from monoterpenoids and low quantities of C13-norisoprenoids (Liang et al., 2020). The latter are characteristics of non-floral grapes, such as Syrah, Sauvignon blanc, Pinot noir or Cabernet (Tufariello et al., 2021).

B. thuringiensis and B. subtilis supernatants did not show any rutinosidic activity in our study. These strains released respectively 12 and 21 μg/kg of benzenoids. These results are greatly supported by the low release of benzaldehyde and benzyl alcohol, which are similar between all the strains (see supplemental table S1). Phenyl acetaldehyde was not released after incubation with both B. thuringiensis and B. subtilis supernatants. 8.3 μg/kg of 2-phenylethanol were detected after incubation of B. subtilis but this compound was not detected for B. thuringiensis. Higher amounts of 2-phenylethanol were observed for samples treated with either B. licheniformis or B. amyloliquefaciens supernatants at respectively, 80 and 21 μg/kg. No monoterpene compound was significantly released by any strain, thus the total amount of monoterpenes remained similar between all the strains. The release of monoterpenes does not seem to be supported by any enzymatic activity evaluated during our study.

- 4) Activities of *B. licheniformis* and *B. amyloliquefaciens* on glycosidic aroma precursors extracted from grape pomace
- 307 Because the glycosidic precursors are different between juice and pomace grape (B. Wilson,
- 308 C. R. Strauss, 1986), the release of aromatic glycosides from an extract of grape pomace,
- measured in the gas phase using a GC-MS, were further characterised by incubation with the
- 310 supernatant of *B. licheniformis* and *B. amyloliquefaciens* (table 4).
- In total, 4421 µg/kg of volatile glycosides were released after incubation of AR2000, and
- respectively 906 and 235 µg/kg for supernatants of *B. licheniformis* and *B. amyloliquefaciens*.
- 313 Any strain could release compounds belonging to the class of norisoprenoids. 1.7 and 5 times
- 314 more volatile compounds were respectively released by B. amyloliquefaciens and B.
- *licheniformis* supernatants in the grape pomace glycosidic extract compared to the grape juice

glycosidic extract. The main released volatile compounds after enzymatic hydrolysis by both strains are reported in **Figure 2**.

The *B. licheniformis* supernatant led to the release of four times more total volatile compounds, 7.6 times more monoterpenoids and 2.4 times more benzenoids than *B. amyloliquefaciens*. Main released terpenoids were geraniol, nerol and neric acid whereas main released benzenoids were 2-phenylethanol, benzaldehyde and homovanillyl alcohol. Means of geraniol, neric acid, benzyl alcohol and 2-phenylethanol were significantly different (*t-test*, P<0.05). For all of them, *B. licheniformis* hydrolysed more volatile compounds than the other strain. While *B. amyloliquefaciens* supernatant showed higher specific activities for both rutin and *pNPR*, the supernatant activities toward rutin were higher for *B. licheniformis* and were similar toward *pNPR* (**table 2**). *B. licheniformis* supernatant displayed higher rutinosidic activity than *B. amyloliquefaciens* and led to a higher release of volatile compounds from glycosides.

Content of both 2-phenylethanol and neric acid were similar between *B. licheniformis* and the control AR2000 (see **supplemental table S2**). If we consider that the commercial enzymatic preparation AR2000 released all the glycosidic grape precursors, then this strain led to the release of the total glycosidic fraction of neric acid and 2-phenylethanol of grape pomace.

#### Discussion

In this study, we developed an approach dedicated to the screening of the most relevant bacterial glycosidases for releasing grape aroma compounds. Hence, we searched for Bacillus spp. producing glycosidases active on rutin and assessed their activities on grape glycosides. We first assessed their diglucosidase activities toward BCIC and pNPC and then we assessed

their heteroglycosidase activities toward rutin and grape glycosidic extract. We also investigated the nature of the released grape glycosidic volatile compounds.

Among the four strains tested, we found that the supernatant of three of them were active on

# Screening of rutinosidase activity in bacteria

pNPR and of two strains on both pNPR and rutin. Several studies focused on the screening of the 6-O-α-L-rhamnoside-β-D-glucosidic activity in fungi (Koseki et al., 2018) but less information about bacteria displaying such activity is available. Previous studies have evaluated the capacity of some bacteria to hydrolyse rutin but none of the Bacillus tested were retained (Neher et al., 2016; Westlake et al., 1959). In 2012, Yang et al. (Yang et al., 2012) discovered that Bacillus sp. 52 produced an α-L-rhamnosidase that could convert rutin to quercetin-3-O-glucoside but not to free quercetin.. Others Bacillus sp. producing α-Lrhamnosidases active on flavonoids were identified, especially toward naringin (Hashimoto et al., 2003; Mukund et al., 2014). In 2017, Zhu et al. (Zhu et al., 2017) found a naringinase produced by a *B. amyloliquefaciens* strain that retained little activity on rutin. In our study, both B. licheniformis and B. amyloliquefaciens hydrolysed rutin but no activity toward para-nitrophenol-β-D-glucoside was detected.. Supernatant contains several glycosidases that could have been involved in rutin degradation. Thus, an  $\alpha$ -L-rhamnosidase could have first released isoquercetin from rutin and quercetin would have been further released by a β-D-glucosidase. Complementary studies, such as purification and characterisation of the supernatant enzymes must be performed to confirm that rutin degradation is carried out by a diglycoside-specific glycosidase. This assumption is consistent with the presence of a strain specific gene encoding a predicted Glycosyl Hydrolase 78 (GH 78) (https://www.ncbi.nlm.nih.gov/protein/ATI75006.1/, website visited the 2021, June 4<sup>th</sup>) in the sequenced genome of *B. licheniformis* ATCC 9789. However, to our knowledge, this is the first time that rutin deglycosylation is carried out by a *B. licheniformis* strain.

#### Monoterpenoids

Monoterpenoids are the compounds responsible for the characteristic floral aroma, and displaying the highest OAVs (Odor Active Value) in Muscat grape (Wu et al., 2019). In our study, the most released volatile compound is neric acid, reaching 378  $\mu g/kg$  of grape pomace. It is not the first time this compound is shown to be the predominant terpene in grape (Dziadas & Jeleń, 2016) but it is usually found in lower concentrations in both Muscat and non-Muscat grapes (Hernandez-Orte et al., 2008, 2009; Jesús Ibarz et al., 2006). While there is not much information about neric acid glycosides in Muscat grape, our results tend to indicate that this aglycon is mainly linked to a rutinosidic moiety. Geraniol and nerol, two monoterpenoids released in our study, display one among the highest OAVs in Muscat grape (Lukić et al., 2017). It is known that rutinose is the main glycosidic moiety of these two volatile compounds in Muscat grape (Flamini et al., 2014; Williams et al., 1982) and their release are of great importance when considering valorisation of grape pomace. No released linalool nor  $\alpha$ -Terpineol were observed for both strains, probably because tertiary alcohols are less susceptible to  $\beta$ -glycosidase hydrolysis than other terpenoids due to steric hindrance with the enzyme (Gil et al., 2005).

#### Benzenoids

- Both 2-phenylethanol and benzyl alcohol were release by B. licheniformis supernantant. It has been shown that these volatile compounds are found more likely in rutinosidic glycosides than in monoglucosides in Muscat grape (Williams et al., 1983). A recent study, which characterised glycosidic moieties of Muscat, showed that neither benzyl alcohol nor 2phenylethanol could have been identified linked to a monoglucoside (Caffrey et al., 2020). These compounds are rarely released in high content by exogenous application of enzymes in grape. Indeed, most of studies focused on application of enzymes from yeasts (Tufariello et al., 2021). Yeasts showed β-D-glucosidic activities, releasing high content of monoterpenoids but very low or no amount of benzenoids (de Ovalle et al., 2021; Gil et al., 2005). When 2phenylethanol was released, it was usually in wine model system and it was related to the fermentation metabolism of yeast rather than to the glycosidic activity (Lukić et al., 2017; Trinh et al., 2010). It might be possible that the usually low releases of both 2-phenylethanol and benzyl alcohol by yeast glucosidases is related to the low contents of β-D-glucosidic precursors of these two compounds. The only opposite example is the release of as much as 81 µg/kg of benzyl alcohol and 696 µg/kg of 2-phenylethanol from glycosidic precursors in Muscat grape by the yeast Kloeckera apiculate (Mendes Ferreira et al., 2001). Thus, the application of both yeast enzymes and enzymes produced by this B. licheniformis strain could lead to the release of both monoterpenoids and benzenoids if they work synergistically.

# Conclusion

B. licheniformis is known for its cellulolytic and proteolytic activities (Baruzzi et al., 2006; Tamang et al., 2016; Vlasenko et al., 2010) but for the first time, a strain B. licheniformis showed a rutin deglycosylation activity. This activity was linked to the revelation of grape aroma potential. It can be a tool for further grape pomace valorisation, through varietal

aromatic production or through flavonoids deglycosylation. The strain showed high activity toward benzenoic compounds, which might be mostly linked to rutinose moiety in grape. Application of such enzymes in grape can target specifically rutinosidic moieties and can avoid off-flavours production led by fungal enzymes side activities. Future work to purify the enzyme(s) involved and to characterise the glycosidic fraction in grape must be considered to ensure direct link between the activity of this strain and the actual rutinosidic-glycoside potential of grape.

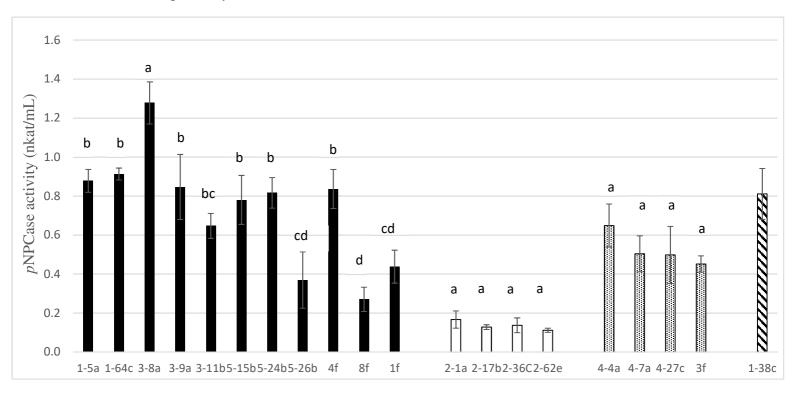

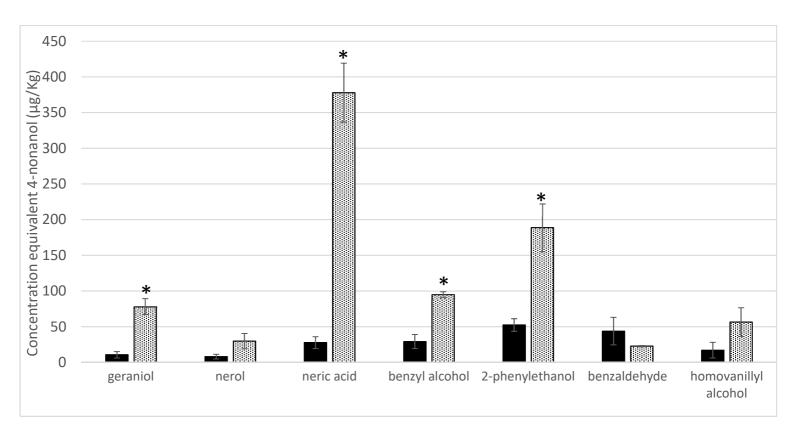
